PUBLIC MEMORANDUM

To: LaSalle Police Services Board

Re: Canadian Civil Liberties Association

Correspondence received from the CCLA, Aboriginal Legal Services, Black Legal Action Centre and the HIV/AIDS Legal Clinic Ontario regarding the LaSalle Police access to Ontario's database of individuals who have had a positive test for COVID-19.

Please be advised that the LaSalle Police Service did not create a database that tracked or stored individuals COVID-19 status. There has been no database of this nature to access.

LaSalle Police communication dispatchers had access to the Provincial Portal while the portal was active. Further, the LaSalle Police did not flag persons or properties on the LPS record management system or any other database regarding COVID-19 status.

In keeping with the provincial mandate, a Chief's Order regarding access to the Provincial Portal was rescinded July 21, 2020.

Recommendation:

That the Board advise the CCLA of the actions taken by the LaSalle Police Service.
